2017–18 Identity/Statement of Educational Purpose Worksheet

Your 2017–18 Free Application for Federal Student Aid (FAFSA) has been selected by the US Department of Education for review in a process called Verification. If there are differences, we will update your FAFSA accordingly. We may ask for additional information. You must appear in person at the Harvard Extension School Student Financial Services Office to verify your identity by presenting a valid, unexpired, government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of your photo ID that is annotated with the date it was received and the name of the official at the institution authorized to collect your ID.

In addition, you must sign in the presence of the Student Financial Services staff member.

If you are unable to appear in person at Student Financial Services to verify your identity, you must provide the information below and sign in the presence of a notary. The original notarized copy of this document must then be provided to Student Financial Services.

- (a) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, such as but not limited to a driver's license, other state-issued ID, or passport; and
- (b) The Statement of Educational Purpose provided below.
